1. Vintage Baby agrees to price your goods to keep prices practical to potential buyers; items will be priced at the discretion of Vintage Baby. **Vintage Baby is not responsible for loss or damage of any merchandise by fire, theft, accident, shoplifting or any other cause.** By signing this contract, I waive any liability to Vintage Baby should any above incident occur. The consignor hereby agrees to hold harmless the Consignee from all damages, suits, litigation, awards & costs, including but not limited to: attorney's fees, which arise out of the consigned goods for any reason whatsoever.
2. To enhance sales, discounts, coupons and sales will be offered on merchandise. Vintage Baby agrees to pay the consignor 45%/50%/60% of the final sale price.
3. **Vintage Baby reserves the right to remove from inventory and donate any item which if found at later inspection to be in poor/soiled/damaged/not saleable condition we will donate.** Holiday clothing can be picked up 1 week after the holiday, then will become property of Vintage Baby.
4. You (the Consignor) are responsible for collecting money & picking up your unsold items. Vintage Baby does not mail checks. After 1 year if cash is not picked up or if in-store credit is not used it will revert to store property.
5. **AFTER 48 HOURS, IF NON-CONSIGNED/NON-ACCEPTED ITEMS ARE NOT PICKED UP THEY BECOME STORE PROPERTY.** Consignments are tagged on a monthly rotation: any items processed from 1<sup>st</sup>-15<sup>th</sup> of the month are tagged for the first of the current month; any item processed from the 16<sup>th</sup>-31<sup>st</sup> of the month are tagged for the 1<sup>st</sup> of the next month.
6. The consignment period is 90 days. **A consignment fee of \$1.00 per month will be charged to each active account. It is the consignor's responsibility to claim merchandise within 7 days of the consignment expiration date. Any merchandise not claimed within the 7 day grace period becomes property of Vintage Baby. NO PHONE CALLS WILL BE MADE.**
